BILL: Prepared a great prime rib from West Coast Meats for the family and spent the rest of the holiday basking in the glow of another Alabama victory.




LARRY: His wife had surgery Dec. 28 to swap batteries which aid her with Parkinson's. He has also been hitting the pickleball courts with his daughter.

Mayor will speak at January 19 meeting

rish Kelley will discuss what's ahead for the City of Mission Viejo and her goals as mayor when she speaks at the Kiwanis Club meeting in two weeks.

She was elected mayor by her peers on the City Council in December. She first joined the panel in 2002 and served until 2014, retiring due to term limits. After a two-year hiatus, she was elected to the Council in 2016 and again last November.

She has been a Mission Viejo resident since 1977 coming to the area when her husband was a pilot at Marine Corps Air Station, El Toro.

She will be inviting questions from members.
